RICHMOND COUNTY OFFENDERS CONVICTED AND SENTENCED SINCE AUGUST 2013 ON FEDERAL FIREARM AND DRUG CHARGES

Effective federal law enforcement presence continues in Richmond County

Greensboro, NC - As a result of continued initiatives focused on violent crime and drug trafficking in Richmond County, the following individuals have been convicted and sentenced in federal court since August 2013.

CASES ADJUDICATED

WARREN DEVIN MOSELEY, age 28, of 120 Withers Road, Hamlet, was federally indicted in the Middle District of North Carolina on August 26, 2013. On October 7, 2013, MOSELEY pleaded guilty to distribution of cocaine. On February 25, 2014, MOSELEY was sentenced to one-hundred (100) months in the Federal Bureau of Prisons to be followed by a four-year term of supervised release. MOSELEY is presently serving his sentence at FCI-Beckley in Beaver, West Virginia.

MARLOW ANTHONY BOWDEN, age 48, of 150 Park Street, Ellerbe, was federally indicted in the Middle District of North Carolina on October 1, 2013. On December 6, 2013, BOWDEN pleaded guilty to being a felon in possession of a firearm. On March 12, 2014, BOWDEN was sentenced to forty-eight (48) months in the Federal Bureau of Prisons to be followed by a three-year term of supervised release. BOWDEN is presently serving his sentence at FCI-Petersburg in Hopewell, Virginia.

KEITH TYRONE ALLRED, JR., age 20, of 181 Crestway Drive, Rockingham, was federally indicted in the Middle District of North Carolina on October 28, 2013. On January 6, 2014, ALLRED pleaded guilty to possession of a stolen firearm. On April 2, 2014, ALLRED was sentenced to twenty (20) months in the Federal Bureau of Prisons to be followed by a three-year term of supervised release. ALLRED is presently serving his sentence at FCI-Williamsburg in Salters, South Carolina.

TIMOTHY ALLEN REGISTER, age 44, of 118 Mill Street, Rockingham, and JOSEPH GAGE ANDERSON, age 22, of 1331 Cauthen Drive, Rockingham, were federally indicted in the Middle District of North Carolina on December 17, 2013. On February 3, 2014, REGISTER

and ANDERSON pleaded guilty to possession of stolen firearms. On May 8, 2014, REGISTER was sentenced to sixty-six (66) months in the Federal Bureau of Prisons to be followed by a three-year term of supervised release. On May 8, 2014, ANDERSON was sentenced to thirty-nine (39) months in the Federal Bureau of Prisons to be followed by a three-year term of supervised release. REGISTER has not received a designation regarding placement in the Federal Bureau of Prisons. ANDERSON is presently serving his sentence at FCI-Beckley in Beaver, West Virginia.

SCOTTIE ALLEN LOFTIS, age 38, of 245 Green Chapel Church, Hamlet, was federally indicted in the Middle District of North Carolina on November 25, 2013. On March 17, 2014, LOFTIS pleaded guilty to being a felon in possession of a firearm. On August 13, 2014, LOFTIS was sentenced to one hundred-twenty (120) months in the Federal Bureau of Prisons to be followed by a three-year term of supervised release. LOFTIS has not received a designation regarding placement in the Federal Bureau of Prisons.

DOMINIQUE RASHAD LITTLE, age 24, of 225 Cabel Drive, Rockingham, was federally indicted in the Middle District of North Carolina on April 28, 2014. On June 5, 2014, LITTLE pleaded guilty to distribution of cocaine base. LITTLE, who is detained in federal custody, is scheduled to be sentenced on October 10, 2014, in Greensboro.

PHILLIP JAMAL JONES, age 27, of 1335 Cauthen Drive, Rockingham, was federally indicted in the Middle District of North Carolina on January 27, 2014. On April 7, 2014, JONES pleaded guilty to bank robbery, and on June 9, 2014, JONES pleaded guilty to carrying and using a firearm during and in relation to a crime of violence. JONES, who is detained in federal custody, is scheduled to be sentenced on September 11, 2014, in Greensboro.

AMY THREATT CAMPBELL, age 39, of 1596 Olive Branch Road, Polkton, was federally indicted in the Middle District of North Carolina on May 27, 2014. On August 4, 2014, CAMPBELL pleaded guilty to possession of pseudoephedrine knowing or having reasonable cause to believe that it would be used to manufacture methamphetamine. CAMPBELL, who is detained in federal custody, is scheduled to be sentenced on November 13, 2014, in Greensboro.

UNADJUDICATED OFFENSES

REGGIE DWAYNE HARRINGTON, age 29, of 402 Marlboro Street, Hamlet, was federally indicted on drug trafficking charges in the Middle District of North Carolina on July 29, 2014. On August 25, 2014, HARRINGTON was arrested on the federal indictment. HARRINGTON, who is detained in federal custody, is scheduled to have his case heard during the October 2014 Criminal Term.

JUAN DASHA PATTERSON, age 22, of 711 McDonald Avenue, Hamlet, was federally indicted on drug trafficking charges in the Middle District of North Carolina on July 29, 2014. On August 11, 2014, PATTERSON was arrested on the federal indictment. PATTERSON is scheduled to have his case heard during the October 2014 Criminal Term.

JOHN ADAM RILLO, age 41, of 2134 N. U.S. Highway 220, Ellerbe, was federally indicted on drug trafficking charges in the Middle District of North Carolina on June 30, 2014. On July 24, 2014, RILLO was arrested on the federal indictment. RILLO, who is detained in federal custody, is scheduled to have his case heard during the October 2014 Criminal Term.

LEE THOMAS SMITH, age 58, of 229 Old Gibson Road, Hamlet, was federally indicted on firearms charges in the Middle District of North Carolina on July 29, 2014. On August 5, 2014, SMITH was arrested on the federal indictment. SMITH, who is detained in federal custody, is scheduled to have his case heard during the October 2014 Criminal Term.

"We are very pleased to be part of the team fighting violent crime and drug trafficking in Richmond County," said United States Attorney Ripley Rand. "The Uniform Crime Report shows that violent crime dropped over 15% in Richmond County in the last year. The effective partnership between Richmond County law enforcement, the office of District Attorney Reece Saunders, and our office will continue to work hard to make our communities safer for all."

The convictions referenced above are the result of close cooperation between the Richmond County Sheriff's Office, the Rockingham Police Department, the North Carolina State Bureau of Investigation, the Bureau of Alcohol, Tobacco, Firearms, and Explosives, the Richmond County District Attorney's Office, and the U.S. Attorney's Office for the Middle District of North Carolina. With respect to the defendants who have unadjudicated offenses, the charges contained in those indictments are allegations. The defendants are presumed innocent unless and until proven guilty beyond a reasonable doubt in a court of law.
